Host institutions: the human geography departments in the universities of Gothenburg, Karlstad, Umeå and Uppsala.

Course description:

This course will explore feminist theory and methods as specifically focused on past and present representations of race, class and gender and its material consequences. This includes disrupting conventional binaries by addressing mobilities and the personal and intimate in the political, economical and global. The course also addresses the persistent power relations embedded within conventions of academic knowledge production.

After first setting out the diverse aims of feminist geography, the course examines three central areas of concern — Feminist geography and global labour studies (Umeå), Gender, work and everyday life (Karlstad), and Intersectional feminism and "doing" feminist geography (Uppsala).

To engage with these ideas, the course combine lectures, readings, workshops/excursions and seminars with a range of extended material (films, art, policy documents).

Course deliverables:

The course requirements involve in-person presence at the three course modules, seminar discussions, submitting written papers, and a final paper. Specific guidelines for the deliverables will be distributed before the course begins.

The language of instruction is English.

Examination will occur by a final paper of approximately 5000 words, on a topic of the student's choosing, relating to the themes of one of the modules. Deadline for the paper will be by the end of January 2024.
